Additionally, PR status is often a step towards obtaining Singaporean citizenship.

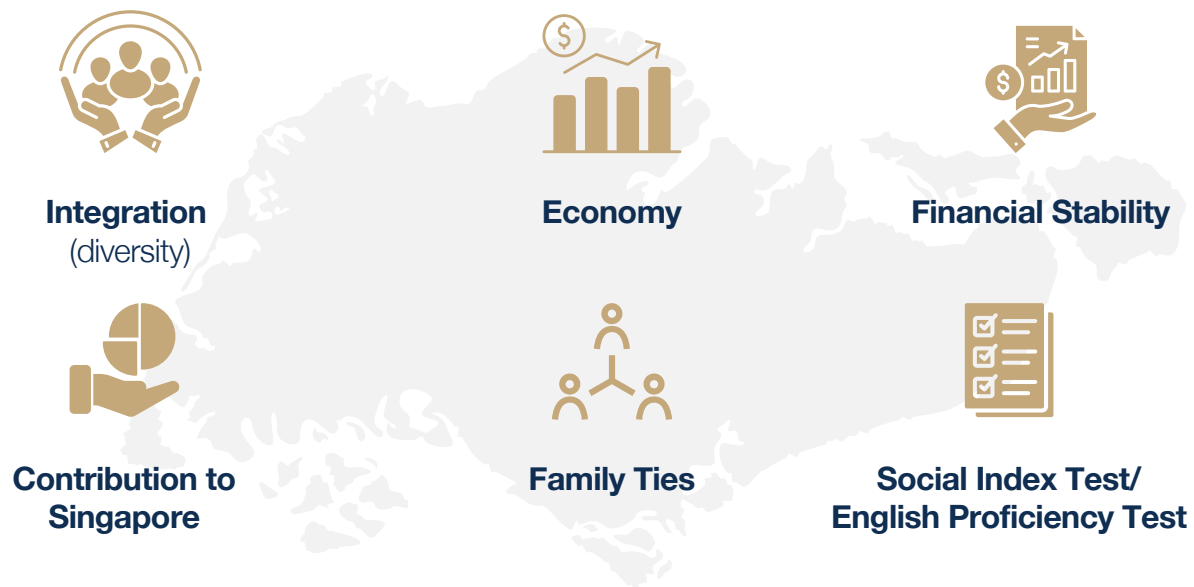
Eligibility Criteria

- Foreign investor under the Global Investor Programme (GIP)
- Employment Pass (EP), S Pass, or Personalised Employment Pass (PEP) holders
- Spouse of a Singapore Citizen (SC) or Singapore PR
- Unmarried child (below 21) of a Singapore Citizen or Singapore PR
- Aged parent of a Singapore Citizen
- Foreign student studying in Singapore

- ✓ **Access to CPF (Central Provident Fund)**
Employers & employees contributing a portion of monthly salaries for future savings and well-being with interests
- ✓ **Job Stability**
Can be hired without work passes or company sponsor
- ✓ **Healthcare System**
High-quality medical services and access to subsidised healthcare costs
- ✓ **Rights to purchase or rent public housing (HDB)**
- ✓ **Competitive Tax Structure**
Favourable for those looking to invest or start a business
- ✓ **Subsidy to internationally**

Visit ICA to submit original documents for verification.
- 9 Issuance of PR Status**
Receiving NRIC (PR identity card) and Re-Entry Permit (REP)

Document Checklists

- Birth Certificate
- Household registration
- Education Certificate
- Payslip
- Payslip and income tax statements
- Marriage Certificate (if applicable)
- Family Background Documents
- Other supporting documents to get higher possibility for approval
- ID Card
- Valid work pass
- Passport
- Letter of employment (from current employer)
- Cover letters (1 from company, 1 self-introduction)
- Children's Documents: Birth certificates, adoption papers (if applicable)

What is Re-Entry Permit (REP)?



Re-entering Singapore document after traveling abroad. It is usually valid for 5 years and must be renewed before it expires.


Processing time: Subject to ICA (Immigration & Checkpoints Authority) review, applicants' documents are typically processed within approximately 6 to 8 months.
